Previous Minutes	Philip asks the committee to approve the previous minutes. DH: noticed a mistake that needs amending regard his presence at the meeting. Kelly to amend but otherwise all approved.			
Arising matters	PB: any arising matters? RG: None from myself. None mentioned, PB moves on the Financials			
Financials	Half Yearly Accounts SM: Overall, the accounts show good control over spend has been shown for the quarterly accounts. All lines are roughly where we predicted they would be. Over the year based on the current spends there is a projected additional surplus in the accounts Renewals are slightly higher than normal, but this is believed to be more of a timing issue and will smooth itself out over the rest of the quarter. The previous outstanding balance from Seasons has now been cleared and it no longer outstanding. Brian will verify this within the end of year accounts.			

Kitchens	RG: Proposed a project to have all of the lodge's kitchens refurbished and paid for by the sinking fund (cap-ex). The idea would be to keep the kitchens very similar but to remove the undercounter fridge-freezer and replace with a tall 70/30 unit, add a wine cooler and a new hob with extraction fan built into the hob itself rather than an overhead unit. The project is awaiting the committee's approval before progressing.		
	The committee and management company discuss the options, and agree that the cost, estimated at £400,000, would be paid for by the Owners Club, using funds from their bank account. The work would be carried out by contractors and spread over 2years. The work will also be looked to be completed around owners weeks, to try not to disrupt their stays.

Resort Update	RG: Not much to update the Committee on since the last meeting. No health and safety matters to bring to attention and all compliance checks are up to date. Any work that needs attentions is carried out accordingly.		
Hotel Update	No updates from the Hotel, there has been very little complaints regarding the hotel. Lots of guests have been taking advantage of the discounts. JF will have a meeting with them upon his next visit to Belton Woods.		
Guest Feedback	Guest feedback is high as usual from Belton Woods. All reviews are investigated and any actions required are either completed upon departure or scheduled for bigger projects.
