Nestled in the charming Hertfordshire countryside, the hotel boasts 126 stylish guest rooms including 16 individually designed Mews Suites, all set within a 12-acre estate. For dining and events, there is also Omboo, an Asian dining experience which also hosts the hotel's very popular daily offering of Afternoon Tea during the day, the Brasserie, Conservatory Bar, Octagon Bar and 15 event spaces perfect for meetings, conferences as well as spectacular weddings and special occasions for up to 300 guests.

Sopwell House is also home to the multi-award winning three storey Cottonmill Spa, a vibrant haven featuring cutting edge fitness, beautiful facilities and world class treatments by the very best British brands. Cottonmill has a 14m indoor pool, gym and two vitality pools whilst The Club at Cottonmill also benefits from a beautiful spa garden, garden rooms and the Whisper Room, an indoor /outdoor hydrotherapy pool, and a suite of thermal treatments.
