TERMS AND CONDITIONS



1. The hotel may require payment in full in advance, or on arrival depending on the terms of the booking. Cheques (personal or company) must be presented in good time for clearance, and will not, under any circumstances be accepted on departure.
2. Rooms will not be ready until 3.00pm on arrival. However guests are welcome to use the hotel facilities and car park if arriving early or staying on later. Room can be pre-booked the night before at an extra charge to guarantee an early arrival. Check out time is 11.00am and late departures will be charged for. However, by written agreement.
3. Subject to availability, a late check out may be arranged for an extra charge, near the time of the holiday.
4. Bookings from persons under the age of 18 years cannot be accepted. The minimum age of children allowed in their own room is 14 years.
5. Groups of single sex parties (five people or over) can only be accepted with prior permission from the Management. If agreed, a disclaimer will need to be completed by the organiser. Please ensure you inform us if you are an all male or all female party.
6. Behaviour of guests and their visitors should not be excessive or rowdy, and must not cause annoyance, distress or embarrassment to staff or fellow guests. Offensive or illegal behaviour will not be tolerated. We reserve the right to recover from the person making the booking any discretionary compensation payment, or discount, that we may have to pay to any other guests, as a result of your actions, or a member of your party or visiting friends. This includes damage to the hotel building, fixtures, fittings and flood damage.
7. Failure to comply with any of the booking conditions may result in the party being asked to leave immediately, if in our sole discretion, we (Tregenna) feel the conditions have been infringed. The accounts will be due in full and no refunds will be given in these circumstances.
8. If Tregenna Castle is prevented by circumstances beyond their control from making accommodation available and cannot provide a suitable alternative, they will refund monies already paid by you, but no further liability will be accepted.
9. Improvements, maintenance and changes to the hotel facilities and grounds take place throughout the year. We will always do our best to ensure guests are not inconvenienced. No compensation will be paid if a facility is unavailable, but we will do our best to provide a suitable alternative. During quieter periods only one restaurant may be open in the evenings.
10. Liability: personal belongings are the responsibility of each member of the party, and items of value can be left in the hotel safe. We accept no liability whatsoever for any accident, loss or damage to your property unless such loss is due to our negligence. Any items of value are logged and kept at the hotel for a period of up to 6 weeks. We cannot be held responsible for the failure of public services (eg water, gas electricity etc) or for any disturbance that is beyond our control. In all cases, except personal injury or death, our liability to you for the total of all

claims arising out of your holiday with us is limited to the cost of the booking.

Tregenna Castle will accept no responsibility for loss of damage to your belongings, personal injury or loss of life. 17. Prices are correct at the time of publication but may change without notice with the exception of confirmed bookings. Confirmed bookings will not alter other than to reflect any changes to tax.
